- Please limit your submissions to one photo per category.
- Submit your image/s with titles in this format:

- Parents or legal guardians must fill out and sign a waiver form for entrants under the age of 18 in order to be eligible and mail to openhouse**newyork**, 555 West 25th, New York, NY 10001 or fax to 212.620.5299.
- Adult entrants must copy the following onto the email and 'sign' by adding their full name below:
- "I have read the competition rules posted on [www.ohny.org](http://www.ohny.org) (link to rules pdf) as of October 11th, 2009 and accept and agree to abide by them and the decisions of openhouse**newyork** inc. which shall be final and binding in all respects."
- Your image/s will be removed if a waiver is not received by October 23.
- The minimum dimensions of each image must be at a 180 pixels wide in JPEG format only.

**Rules:**

- Acceptance of Rules: By entering, each entrant and the entrant's parent or legal guardian accepts and agrees to be bound by these rules and the decisions of openhouse**newyork** inc, which shall be final and binding in all respects.
- Contest open to legal U.S. residents.
- Employees of openhouse**newyork** are not eligible.
- Entries will be judged on 3 criteria: creativity, quality of photograph and significance to the theme.
- No responsibility is accepted for incomplete entries due to mail provider malfunctions or other causes beyond our control.
- Winning entries will be chosen by our panel of judges. The judges' decision is final and no further correspondence will be entered into.
- The entrant guarantees that (s)he is the sole owner of the work and that the work does not infringe any copyright, violate any other property rights, contain any scandalous, libelous, or unlawful matter, or make any improper invasion to the privacy of any person; that the work has not as a whole heretofore been published; that (s)he is the sole and exclusive owner of the rights.
- All entrants agree that their name and images can be displayed on openhouse**newyork**'s website and in openhouse**newyork** marketing and advertising without charge. By entering the competition and signing the waiver form you have confirmed this authorization. Images will not be displayed in any other way without the permission of the artist, and all entrants retain copyright for all images submitted.
- Parental Consent Required for entrants under the age of 18. By participating in the contest, each winner's parent or legal guardian consents to the use of his/her child's name and/or photograph for advertising and publicity purposes without additional compensation. Rules are subject to the requirements of the Children's Online Privacy Protection Act (COPPA).
- Entries become the property of openhouse**newyork** inc. and will not be returned.
- Winners will be notified by email within 45 days of the end of the competition and announced in openhouse**newyork**'s newsletter. Winners' details and images will be posted on openhouse**newyork**'s website within 60 days of the end of the competition.
